Security at the Courthouse

Ever get frustrated with taking off your jewelry, belt, and shoes, emptying out your pockets or purse, and proving that your drink is not really a liquid explosive when you come to court? Well, there are reasons for the madness. While we all used to be able to walk freely through the courthouse doors, serious security issues arose several years ago requiring the County to review its security measures and balance the safety of the staff and visitors to the courthouse, with the inconvenience of security checkpoints.

Basically, security is handled by three different agencies, overseen primarily by the Washington County Sheriff's Office. First, you have Olympic Security in charge of the entrances. There are metal detectors at both the 1st and 2nd street entrances, as well as to the Juvenile Bldg. They open the doors at 8:00 a.m. and close at 5:00 p.m., Monday through Thursday and are open until 7:00 p.m. on Fridays for the Probation Department. Every person is screened, unless in uniform or showing a special police ID badge. The items they screen for are just like at airports (minus the shampoo issues). They most often collect items such as pocket knives, leatherman's, and knitting needles. They have also discovered drugs, drug paraphernalia, and guns (hidden in diaper bags and even a lawyer's brief case!) For most items, people are given the opportunity to return the items to their cars. With regards to food and drink, if you are bringing any opened container into the courthouse, they will require you to take a sip of it to prove it is not a liquid explosive. If you have special requirements, such as wheelchairs, strollers, walkers, etc., the security staff can use a wand to make sure you are not carrying any weapons. If you have a pacemaker, or artificial limb or joint, it is helpful to carry a card of explanation. Also if you are accompanied

by a health care/medical needs dog, you should have the appropriate paperwork with you, but access will not be denied as long as the pet remains well behaved. Second, the Washington County Sheriff's Office is in charge of courthouse security and transport. They will normally be the uniformed Sheriff's deputies you see on a regular basis. They are here to transport prisoners from the jail, and to pick up those being placed in custody. They also are responsible for searching the courtrooms each day. Finally, DePaul provides the security after hours for the grounds and for the parking lots. Anyone working late hours can call them and ask for an escort to their car.

Employees of the County and State Court facilities, along with county employees who have business in the courthouse, are issued a MAG card upon employment. This allows them entrance to the courthouse through several locations, thus avoiding security screening. Other licensed professionals, such as lawyers, private investigators and interpreters, may apply for a MAG card. The cost is \$25 (or for replacement if lost) and use may be suspended for misuse, such as allowing clients in, without having them go through screening. The key is to remember that access by way of the MAG card is personal to you, alone. New lawyers, or others without MAG cards are highly encouraged to apply for one. It will speed up your entry into the courthouse, and help avoid the long lines at the entrances.

So, if you find yourself in line behind twenty other people, and it's raining, or you are in a hurry, please remember to remain patient, courteous and polite. Security is there for us. They are there to do their job and to keep everyone safe.

President's Message

In this column last month, I noted the growth of Washington County and the numbers of lawyers practicing in Washington County. In the course of that discussion, I paid homage to the "good old days" when most of the lawyers knew each other personally and when those personal relationships served the entire system by engendering trust and communication between practitioners. Forgive me for getting all preachy, but I wanted to add some observations about

the current state of professionalism and practice in Washington County. (And, hey, you try to come up with something new and profound to prattle on about each month in a Bar newsletter!).

We all know that lawyers, especially litigators, are competitive by nature and that being assertive and competitive serves the interests of our clients. However, I find it troubling that so many lawyers find it difficult to separate their personal feelings from their professional advocacy.

In my current position as the Director of the Public Defenders Office, I hear it most often from defense lawyers who complain that Deputy District Attorneys can't seem to separate their contempt for the reprehensible conduct of some of our clients from their feelings toward the attorney for the defendants. We see this in the form of anger and personal attacks directed at defense counsel at various times in the heat of litigation and it seems many are willing to immediately assume bad faith on the part of defense counsel due to their association of the attorney with their client.

And this certainly applies to defense attorneys, as well. I have also seen defense lawyers, caught up in their righteous indignation about the perceived injustices suffered by their clients who vilify district attorneys as callous oppressors when the Deputy DA is simply doing the best they can to enhance the safety of the citizens of Washington County. In my opinion both sides are far too quick to assume the worst about the advocate for the other side and assume bad faith when routine problems arise. In my prior incarnation as an attorney in private practice, I also routinely saw this dynamic arise in domestic relations cases when attorneys got their own emotions embroiled in the emotional roller coaster of their client's case. I think it is accurate to say that the judges don't have a lot of patience or respect for lawyers who take this approach in court.

In all cases, it seems clear to me that professionalism requires that every litigator strive to rise above the fray and to keep these matters in perspective. And this brings me back to the Washington County Bar Association. It's been my experience that even if you don't particularly like the attorney for the other side (or the position for which they advocate), getting to know the other counsel and building a personal relationship is the easiest and best way to diffuse these problems, reduce the normal stress of litigation and to make everyone's lives easier, including those of your clients. It has also been my experience that once you get to know opposing counsel, and they you, trust follows. A conversation or a beer with someone you don't know well at the Bar meeting each month seems like a pretty good place to start.

Council on Court Procedures: Press Release

Where do the Oregon Rules of Civil Procedure come from and how are they changed? If a particular rule is not effective or has been rendered obsolete by technology, or by practice, how may it be amended? The Council on Court Procedures was formed by the Legislature in 1977 to draft and to systematically update the Oregon Rules of Civil Procedure (ORCP). The enabling legislation is found at ORS 1.725 through ORS 1.760. Well-crafted, fair, and balanced procedural rules for the filing, prosecution, and defense of civil disputes ensure that all Oregonians have a forum in which to seek redress of private grievances fairly and equitably.

By statute the Council is composed of lawyers, judges, and at least one public member. The lawyers are further sub-divided into two equally numbered groups: one drawn from the ranks of the "plaintiffs' bar" who routinely represent those seeking redress; and one drawn from the "defense bar" who routinely defend cases. The judges are drawn from the trial courts, the Court of Appeals, and the Supreme Court. All members of the Council are volunteers who serve without compensation.

The Council meets once each month during the years between legislative sessions. Meetings are on Saturdays and usually begin at 9:30 a.m. Committees and task forces established by the Council meet at various times during the month, depending upon the work load and the schedules of individual members. The Council votes to publish proposed amendments to the ORCP at the September meeting in even numbered years and votes to promulgate amendments to the ORCP at the December meeting in even numbered years. The Council's promulgated rules or amendments are submitted to the Legislature and take effect in January of the following, odd-numbered, year, unless the Legislature votes to amend, repeal, or supplement any promulgation.

The Council's meetings are open to the public. Meetings are held at various locations around the State. The next meeting is Saturday, November 10, 2007, at the Oregon State Bar offices. The Oregon State Bar provides meeting space at no cost to the Council. The Council also meets in other locations and for the most part receives in-kind contributions of the cost of meeting space.

Trial judge members of the Council are appointed by the Circuit Court Judges Association and include: Hon. Daniel L. Harris (Jackson County, Term Expires 8/31/09); Hon. Robert D. Herndon (Clackamas County, Term Expires 8/31/09); Hon. Jerry B. Hodson (Multnomah County, Term Expires 8/31/11); Hon. Lauren S. Holland (Lane County, Term Expires 8/31/09); Hon. Rodger J. Isaacson (Klamath County, Term Expires 8/31/09); Hon. Mary Mertens James (Marion County, Term Expires 8/31/11); Hon. Eve L. Miller (Clackamas County, Term Expires 8/31/11); Hon. Locke A. Williams (Benton County, Term Expires 8/31/09).

The Court of Appeals appoints one of its members, currently Hon. David Schuman (Term Expires 8/31/09). The Oregon Supreme Court appoints one of its members, currently Hon. Rives Kistler (Term Expires 8/31/09). The Board of Governors appoints a public member, currently Dr. John Enbom (Corvallis, Term Expires 8/31/09).

The Council's current officers are Don Corson, Chair; Eugene H. Buckle, Vice-Chair; and Dr. John A. Enbom, Treasurer.

The Council is continually addressing whether the Oregon Rules of Civil Procedure are serving to fairly and efficiently resolve civil disputes for the benefit of parties and their attorneys. The Council welcomes reports of instances where a rule is not, or is no longer, meeting the fair and efficient standard. News from the Family Court Team

- 1. Support Supplemental Judgments. If a party who was previously ordered to pay support is no longer required to pay (particularly through change of custody), make sure that the body of the order terminates that parent's ongoing support order. If the support clerk fails to notice it, Salem will continue to bill and enforce it including with a withholding order. The clerks always check the money award section but sometimes fails to notice an item in the body of the judgment. For that reason, some practitioners are creating an additional money award showing a \$0 payment for the party for whom support is terminated.
- 2. General Judgment After Limited Judgment of Support. A limited judgment (pendente lite order) of support establishes support until the next order of the court. Any sums accumulated under that judgment continue to be enforceable even after the general judgment is entered. The limited judgment should be satisfied to the extent that it is paid, ideally in a separately filed satisfaction or, at least, in the general judgment. If it appears in the general judgment, it should also show as a satisfaction in the money award section.
- 3. <u>Priority of Money Award.</u> If the money award differs from the body of the judgment, the clerks will use the money award information. Please proofread your documents carefully.
- 4. Probate Department. The probate department will be within the Family Court Team. A clerical supervisor is being hired who will supervise family law, juvenile, and probate. Judge Cobb will continue to preside over probate.
- 5. Lawyers for Children. The Family Court team has compiled a list of about 20 attorneys who are willing to accept appointments to represent children on an initial pro bono in family law cases. Most of these attorneys attended the CLE on representing children presented by the Washington County Bar Association in June 2007, or have attended other CLE's on the topic, such as the OAFLP CLE on this topic held in February 2007. Attorneys who are interested in being added to Court's pro bono list should contact Judge Thompson. Pro bono attorneys are typically appointed in cases where neither of the parties are represented by attorneys and where a child has requested an attorney or complex issues are present. Although the initial appointment is pro bono, a fee payable by one or both of the parents may be awarded at case conclusion if requested. Interested attorneys may wish to attend the CLE on Effective Representation of Children sponsored by Child Centered Solutions and Samaritan Counseling Centers on November 30, 2007. Several of these attorneys have already been appointed and some very difficult cases have been resolved, for which the Court is very grateful. The Family Court Judges will also consider attorneys on this list for appointment on fee (non pro bono) cases as appropriate.
- 6. Support Worksheet Glitches. There are glitches in the support calculation worksheets. One work-around is this: with a 50/50 parenting plan, have the larger income parent as Parent 2. Otherwise the amount and the obligor may be wrong.

WIRELESS ("WIFI") IN COUNTY LAW LIBRARIES AROUND OREGON

Our wireless service will get a new password (also called a passkey) on November 26th, 2007. In case you hadn't already guessed, yes, the Washington County Law Library has wireless access to the Internet. Other county law libraries also have wireless access, including Multnomah, Marion, and Clackamas counties. Ask at library service desks for log-on information.

A BIG WIRELESS BOOST FOR A SMALL PRICE

After we installed our wireless internet access at the Washington County Law Library, we had several complaints about weak connections and signal strength. Our webmaster and tech guru, Carissa Barrett, researched various fixes and recommended we purchase a high-gain router antenna in an effort to improve signal strength and distance. We purchased a \$39.99 model. The installation was as simple as unscrewing the existing antenna on the router and screwing in the cord to the slightly larger new antenna. The result was an immediate and drastic improvement. We are now able to get excellent signal strength in all corners of the library, including in the conference room with the intermediary doors closed.

Type the word Oregon and run your search. Then click on "search by date" (way over on the right - very hard to see) to get current news. A list of recent blawg posts that mention Oregon will appear. There are other quick ways to search for Oregon legal news, but I'll save those search tips for the next newsletter.

OLPC

OLPC stands for One Laptop per Child and you may have heard about it first as the \$100 laptop initiative that started a few years ago. 10 top things to do to make your Law Practice or Office "Green"

Thanks to Dick Roy who was our guest speaker for our WCBA Dinner on November 12. His ideas were enlightening and, combined with information from the County, we have compiled a list of the 10 top things to do to make your Law Practice or Office "Green."

- 1. Use alternative transportation to get to and from work. If there are none available, at least walk to lunch or do your errands locally.
- 2. Recycle, recycle, recycle
- 3. Avoid even plastic water bottles use your tap water (get filter if you have to)
- 4. Bring in a plant (not plastic!)
- Always use durable dishware and a refillable mug for your lunches and coffee

- 6. Turn off the lights if you are not using them.


