# CONCILIATION SERVICES UPDATE

As many of you may already know there have been some policy and procedural changes at Washington County Conciliation Services. Here is a brief update of recent changes and events.

The economy has taken a toll on Court services in many different ways. The way in which Conciliation Services has been impacted is through filing fees and waivers. Conciliation Services is primarily funded by a portion of domestic relations filing fees. A small portion of our budget is also funded by marriage license fees, domestic partnership fees and custody and parenting time evaluation fees. Fee waivers are on the rise due to the economy and the ease with which users of the Court system can now obtain a fee waiver. Thus, Conciliation Services' revenue has significantly decreased. This has impacted our ability to fully staff the program.

To address budget concerns Conciliation Services took steps to request an increase in the portion of filing fees designated to support the program. This request was approved by the Board of Commissioners and implemented in July 2009, resulting in an increase in domestic relations filing fees.

Early this year Conciliation Services saw a significant increase in the number of custody and parenting time evaluations being ordered. This lead to a large backlog of cases. We have stopped accepting referrals for evaluations because of this backlog and because of staffing issues.

We have also noticed a number of cases referred for custody and parenting time evaluations that have very limited issues. Some cases, from our perspective, do not rise to the level of needing a comprehensive evaluation. Historically we have performed comprehensive evaluations on all cases per our policy and best practices. We are now looking at new models for evaluations, including shorter and more focused evaluation models. Our goal is to provide services to clients that match their needs and the needs of their children, as well as following accepted best practices within the field. As we do research and become more prepared to implement a new evaluation practice, Conciliation Services will be reaching out to our community partners, including the family bar, for input and to provide information.

Conciliation Services has recently changed our practice with respect to mediation agreements. Mediators are now sending any *written and signed* agreements to the assigned judge *seven days* after the agreement was signed. Attorneys identified by the parties will immediately receive these agreements once they are signed. Clients are informed of this protocol verbally and in writing and at mediation orientation. We also encourage and support attorney review of any agreements reached in mediation.

My staff and I encourage anyone to

call us with questions, concerns and feedback about our practices and policies. Our ultimate goal is to provide the best quality of service to clients, while helping them reduce conflict and maintain a healthy co-parent relationship.

I would like to express my appreciation to all of those who have supported Conciliation Services as a program and individually during some very difficult times. I especially appreciate the patience judges, attorneys and court staff members have extended to the program as we manage fiscal and policy changes. Most importantly I would like to say "thank you" to the wonderful staff at Conciliation Services. They have worked hard to manage a high caseload and ever difficult clients in a challenging time. To Amy Baker, David Traisman, Alex Vidal, Cindy Carr and Carol Swoboda – thank you so much for your amazing work ethic, commitment to clients and undying support for children in our community.

### RACE FOR JUSTICE RAISES \$145,000 FOR ST. ANDREW LEGAL CLINIC

The 9th annual Race for Justice for St. Andrew Legal Clinic (SALC) rocked NE Portland on June 20, beginning and ending at the beautiful Madeleine Parish on NE 24th St. This year, a record-shattering 720 walkers, runners, and volunteers showed up to participate in the 3.1 mile course and more than 100 volunteers signed up to assist, making this the biggest R4J crowd ever. The Kids' Fun Run attracted 60 pint-sized participants, who completed their route before retiring to post-run ice cream cones and root beers.

The adult walk/run starting line bustled with 700 contestants, who got off the mark at 10:15. The earliest finish was 15:50, completed by Mike McGrath. The après-run party entertainment included free beer from Rogue Brewery and piping hot pizza. The coveted traveling bronze sneakers were awarded to Prevailing Parties and Stahancyk, Kent, Johnson & Hook for Best Fundraising Team and Largest Team, respectively. The famed Markowitz Challenge was awarded to Douglas Way Dawdlers, Prevailing Parties, and Ball Janik. This year Reinisch Mackenzie won the new Workers' Competition Award for Largest and Best Fundraising Team among workers' compensation firms. Winners of the inaugural Charlie Coulter Family Law Challenge Award were: Gevurtz Menashe, Stephens Margolin and Meyer & Wyse. In the challenge between the Oregon Department of Justice and the Oregon Public Defense Services, the DOJ won for both Fastest Team and Best Fundraiser.

An amazing \$145,000 was raised this year to benefit SALC. Proceeds from the race, as well as direct community donations, allow low-income families access to quality family law services on a sliding scale. SALC is committed to providing security for children, support to women in crisis, and access to justice for the working poor.

SALC maintains offices in Washington, Multnomah, and Clackamas counties. Client intakes are performed by volunteer attorneys under the supervision of a regular staff attorney. Normally having fewer deputies available would mean fewer visiting hours for the public and professional visitors. However, thanks to innovative ideas from our jail staff, we implemented a series of schedule changes to meal times and other programs, so we are actually able to increase the number of available visiting hours from 36 to over 49 hours per week!



**UTCR 2.130 FORMS**. Each litigant has to complete the form under 2.130. A party seeking to have the confidential information limited away from the opposing party can apply at


ex parte for an order limiting disclosure of that information. If somehow your pleadings include the confidential information in some form or another, eg. Uniform Support Affidavit or

### WITHDRAW TO AVOID

HEARTACHE. Please submit a withdrawal of representation when you have completed a case, one for each case, even if there is a consolidation order. Recently we had a FAPA renewal which was contested. The notice of hearing went to petitioner's old attorney who had not withdrawn from the FAPA case (but had withdrawn from the associated dom rel case). The petitioner never found out about the hearing date and the renewed FAPA was dismissed because of her unexplained non-appearance. Now it's a huge headache for the lawyer, the litigants and the court.


FINANCIAL CRISIS. We have partially survived the 7.5% reduction in the OJD budget by not replacing staff who left. But it also means that we are way down on support staff with no realistic expectation of change in the foreseeable future . We lost full-time Referee Nancy Hochman. Our staff will also be required to take furlough days which will keep the courthouse open but skeletonized. We are grateful that things aren't worse, but we have had to change some procedures to meet the realities. The State Court Administrators office has been decimated and there is no staff person currently monitoring the state on line forms which many self represented individuals use. . If you are referring individuals to a website for forms, please use: courts.oregon.gov/ Washington for our local forms.

**EX PARTE**. You have probably noticed that ex parte is now only at

8:30 am. We encourage you to drop off non-essential ex parte documents for signature rather than running them through ex parte, although we understand sometimes it really is necessary.

FAPA APPLICATIONS. The family law judges are doing FAPA & Elder Abuse applications on a monthly rotational basis.
