WCBA Board of Director Volunteers Come Forward by Sharon Brown, WCBA President

Nicole L. Schneider obtained her Bachelor of Arts and Juris Doctor degrees from the University of Nebraska, graduating from the latter in May of 2000. She was born and raised in Lincoln, Nebraska and was ready to experience other places after graduation. She moved to Portland in 2000, and in April 2001 was admitted to the OSB. She practiced primarily in the area of Social Security Disability until January, 2009 when she joined the Beaverton law firm of Helzer & Cromar LLP, where she is a partner. She practices Social Security Disability law, domestic relations and general law matters. She volunteers her time at the St. Andrew Legal Clinic and the Hollywood Theatre. She is also involved in the Broadway Rose Theatre Company. Nicole describes herself as enthusiastic, and believes she has a perspective that will be of benefit to members of the Washington County Bar and the board. nal law issues such as Restraining Orders (FAPA's) and Stalking Protective Orders (Civil and Criminal). Amy has been a member of the Washington County Public Safety Coordinating Council since 2008, and was nominated by Judge Thomas W. Kohl and elected to serve as vice chair of the council for 2009. Amy has also volunteered to join our Washington County Board of Directors as a member at large.

Rebecca Guptill was born and raised in Oregon, graduating as Valedictorian of Waldport High School in 1998. She received her Bachelor of Arts degree in Print Journalism cum laude from the University of Southern California Annenberg School for Communication in Los Angeles in 2002, and her Juris Doctor from Willamette University College of Law in 2005. Rebecca previously worked as an associate attorney at Ridehalgh & Associates, LLC and Cummins, Goodman, Fish, Denley & Vickers, PC, practicing in various areas of civil and criminal law. Family Law Bench Bar Committee News by Becky Mehringer

The Family Law Bench Bar Committee met in March to discuss the "Best Practices in other Counties." The guest speaker was Lucinda Giorgetti, who spoke at length about the practices in Clark County, Washington. Many of the practices implemented in Clark County save court time and money. Some of the practices are as follows:

- The burden and responsibility of the pre-trial docket is on the attorneys
- Commissioners handle many of the hearings
- The parties can elect an "expedited trial" format in which the attorneys present their case through statements and documents, but no other witnesses (except experts). The evidence rules are less rigid and the judge weighs the documents in making their decision
- There are Mandatory Judicial Settlement Conferences for family law cases, with a Settlement Conference Affidavit which includes all assets and liabilities, the proposed distribution, child support,

- spousal support, and parenting plans. This is assigned to a Judge, but not your trial Judge. If this is not filed in a timely manner, penalties are assessed.
- Once the trial is set, there will be no continuances.
- Clark County allows a single page attorney withdrawal, no motion or affidavit

Also coming out of this meeting were discussions of what our county could do in addition to what is already implemented. Discussed was utilizing the County website in manner to get information out in a more effective manner, expanding the pro tem list (possibly using pro tems for family law mediations), recruiting volunteers to help at the courthouse with family law matters, creating a process that allows parties to get to mediation quicker (possibly by eliminating the requirements that parties attend both parent education classes prior to mediation), stipulated set-overs by telephone (instead of by motion), and re-vamping the existing process of settlement conferences, possibly adopting Clark County's practice of Mandatory Settlement Conferences.
