Profile Judge Oscar Garcia by Kathy Proctor

Governor John Kitzhaber appointed Oscar Garcia to fill the vacancy on the Washington County Circuit Court left by Judge Price's retirement. Before his appointment, Judge Garcia worked in private practice where he represented indi-

viduals in the areas of criminal defense, family law, support enforcement, restraining and stalking orders, civil commitments, juvenile delinquency and more. Judge Garcia was also a Federal Panel attorney qualified to take Federal Court appointed cases and he was an advisory attorney to the Consulate of Mexico.

During his time in private practice, Judge Garcia demonstrated his leadership and commitment to the community by volunteering as a member of the Oregon State Bar unlawful practice of law committee, participating in the OSB Leadership College and serving as an attorney mentor and speaker for groups of students interest in legal careers.

In addition to his busy life as an attorney, Judge Garcia's background includes military experience going back to 1987 when he was in the Army R.O.T.C. During my interview with Judge Garcia for this article, I asked him how his military training might help him in his new role as a judge. He responded that the military was good at training leaders. He learned to become a leader and to make decisions with confidence. He added, in the military he had to deal with explosives so he quickly learned how to be calm in a tense situation. With a slight smile, he added he knows how to deal with chaos.

Judge Garcia didn't have a lot of time after his appointment to relax before starting his new job. He quickly transitioned out of his private law practice and into his new role as a judge. Just days after his appointment, Judge Garcia was personally sworn into his judicial office by the Chief Justice of the Oregon Supreme Court, Justice Paul De Muniz. Judge Thompson's courtroom was filled to capacity as practitioners, judges, retired judges, and court staff observed the ceremony. Notable attendees included Federal District Court Judge, Marco Hernandez, who served as a circuit court judge here in Washington County before his appointment to the Federal Bench, Washington County District Attorney Robert Herman and, Lane Borg of Metropolitan Public Defenders. Following the swearing in ceremony, Judge Garcia commented that he ultimately hopes to be remembered as a judge who worked hard and started work on time. He believes litigants should be heard and to have their day in court in a timely manner. His goal is to be impartial, to hear the parties, consider the evidence, and then make a decision.

Judge Garcia says he believes in a team approach which may serve him well as Washington

County's newest family law judge. He knows that the family law court often sees pro se litigants who may present a challenge since so many emotions are involved in these cases. He is aware that he will preside over tough issues and deep emotions in family law cases, but he is prepared to be patient and use his communications skills to navigate through and get to the legal issues that are before the court.



As he settles into his new role, Judge Garcia's procedures for handling ex parte and other matters may change as he expects there to be an evolutionary process as he settles into a routine. He intends to keep up with technological changes to improve the speed and efficiency of his court. As an example, his judicial assistant Robbin Lake wants attorneys to know that limited information such as trial memorandums, hearing memorandums and even asset/liability statements can be e-mailed to the judge by noon the day before trial through her at <u>robbin.lake@ojd.state.or.us</u>. Don't forget to copy the opposing attorneys an extra trip to the courthouse and eliminates having to pay the copy charges to send a facsimile of your memorandum to the court.

I asked him how the attorneys who appear before him can help him. He replied that he himself expects to be prepared and to be respectful to all the people in his courtroom and he expects the attorneys to do the same. He is open to suggestions on how he can do things better in his court too. When I asked about newer attorneys, he said he plans on being approachable and hopes that new attorneys will solicit advice from him on how they can do better, saying, "We all have to start somewhere."

AFTER-HOURS KEYS

If you are a law library user, please consider applying for an After-hours Access Key.

We may have to cut law library hours or we may experience last-minute, short-term closures, due to budget cuts that have affected our ability to hire on-call staff. (County law libraries are now funded by the state.)

The law library will notify everyone about any permanent or long-term closures, by telephone, on the Law Library county website, or via email, but timely notifications will not always be possible for last minute, short term (2-4 hours) closures.

One way to make sure you have 24/7 access is to have a Washington County Law Library after-hours access key. If you don't have a key, you may apply for one. (You need to be a member of the OSB and live or work in Washington County.) If you have a Washington County Courthouse key, you don't need an additional key; we just put another access code on your existing courthouse key. But you do still need to apply for the law library key. We can email you the application form and instructions, but you will need to sign the application and pick up the key in person. There is currently a one-time county Facilities Department charge of \$25 for the key.

LAW LIBRARY BOOK DROP-OFF at PUBLIC LIBRARIES

Don't forget that you can now drop off your Washington County Law Library books at your Washington County (WCCLS.org) public library, e.g. Forest Grove, Hillsboro, Beaverton, Cedar Mill, etc.

You can use your public library outside drop-box, too. When you check out your Law Library books, please ask for a return-envelope at the law library reception desk.

LAW LIBRARY CHECKOUTS

Say goodbye, mostly, to our carbon copy checkout slips. The Law Library is migrating from paper checkout slips to barcode scanning.

What does this mean for you? Instead of taking home your copy of that easy-to-lose, yellow paper checkout slip, you will receive an email record of your circulation transaction - and an email reminder if your books are overdue.

In order to complete this project, we need to create a "patron record" for you. If you check out our CLEs or books, give us a copy of your business card the next time your visit the Law Library and we'll be ready to go the next time you check out an item. A Tribute to John Ryan

On December 19, 2011, long-time Oregon lawyer John D. Ryan passed away. During his more than fifty years of meritorious service in the practice of law, John contributed to the community at large, as well as the bench and bar. He was a proud member of the Washington County Bench and Bar.

John attended Grant High School in Portland, and Fordham University in New York City. He was dedicated to serving others at a young age. This was especially evident while in college when John convinced the Dean at Fordham to begin a summer school program to allow him and his classmates the opportunity to graduate early so they could enlist and serve in World War II. After his military service, John studied law at Northwestern College of Law (now Lewis & Clark Law School).

John was a true friend to the community. He believed in and was a staunch advocate of fairness for all. In order to achieve this, he felt strongly that everyone should have access to the courts. John was devoted to helping those in need reap the benefits of the judicial system. He understood the power of words; and developed a literacy program in the Armed Forces for members of the military. His dedication carried on into his civilian life. In Portland, he helped to establish the Londer Learning Center, which offered literacy and GED programs to assist those who had criminal histories. John felt that the best way to help people was to arm them with information, and he worked tirelessly to do so by teaching them to read and encouraging them to pursue an education.

I had the opportunity to interview Richard Helzer, who considered John a mentor and a great friend. In 1980, Richard began practicing law with John at a time when Richard felt somewhat confounded and was seeking a guiding beacon to the courthouse steps. They eventually formed a partnership - Ryan and Helzer. In the early 1990's, they moved their offices from Portland to Beaverton, intending to become a "boutique" law firm. However, they never understood the practice of "boutique" lawyers. They frequently represented clients who had no ability to pay legal costs and fees. Richard said, "John believed that justice was not only blind but more often than not, insolvent." He championed the causes for many who otherwise would not have had access to a lawyer for court appearances.

Richard describes John as a renaissance man. He was a scholar of the law and for a time, he taught Torts at Northwestern School of Law. Regarding representation of clients and presenting a case, John believed there was no substitution for preparation and hard work. John had an inquisitive approach to the law. He was often the attorney whom other attorneys would turn to when they felt their cases needed a fresh approach. John avoided arcane ideas of the law.

John's legacy of service inspires us to share our legal knowledge and better serve our community and profession.

Special Request from Court Staff

For all pleadings, attorneys and staff drafting pleadings should including the full five digit bar number of the attorney. Court staff is currently in the process of updating and inactivating the five digit numbers in the system, but often see attorneys are still only using their former five digit numbers, which may contain old contact information. This could result in important court notices being sent to incorrect contact addresses. Please pass this information along to members of the legal community and their staff.
