Ricardo J. Menchaca Washington County Judge

WCBA welcomes Judge Ricardo J. Menchaca who was appointed to the court to fill the unexpired term resulting from Judge Gayle Nachtigal's retirement. Judge Menchaca's first date on the bench was September 3, and he hit the ground running, with a full docket of dependency proceedings in the Juvenile Court.

Judge Menchaca has had a varied legal career and will bring to the court a wide range of legal experience. He was an previously an attorney with the Metropolitan Public Defender, the Department of Justice, an associate lawyer at Smith Freed, and an in-house counsel doing insurance defense. Most recently, he was in private practice in Hillsboro, with a focus on juvenile law and personal injury.

Judge Menchaca received his Bachelor's degree from Oregon State University in Political Science. He is a graduate of Thomas M. Cooley Law School and was admitted to the Oregon State Bar in 2000. When asked about his appointment and his first day in the Juvenile Court, he responded that he's honored to serve and "it's a dream come true." Judge Menchaca believes the court has the ability to improve people's lives. He stated, "You're not going to make everyone's life better but if everything falls into place, you can make some people's lives better." Judge Menchaca believes a judge has the ability to help solve conflict. His understanding of people and the need for a resolution of problems is a challenge he welcomes. He believes in the judicial process and he's dedicated to the fair administration of justice. He is looking forward to a collegial relationship both with the other judges and the bar.

Judge Menchaca wants lawyers appearing before him to be comfortable. He opines that lawyers are likely to do their best work when the judge is cordial. He wants his courtroom to be "a user-friendly environment." Being assigned to the Washington County Juvenile Court is a blessing for both the court and Judge Menchaca. He feels that even with the Juvenile Court's busy docket, his team can all strive toward the goal of making a positive influence and change in young people's and parents' lives. He has a wonderful staff, and is most appreciative of their commitment. He works closely with Marsha, Vera, Cassandra, Sara, Natalie, and Lisa. He's also appreciative of Judge Michele Rini's accessibility and her patience with the

questions he asks of her.

Judge Menchaca has an active judicial docket and in his free time he enjoys spending family time with his wife and his three-year-old son. He enjoys sports and is an avid fan of the Trail Blazers and the Oregon State Beavers.

Family Law Bench/Bar Report

On Monday, September 23, the Washington County Family Law Bench/Bar Committee held its annual open meeting at the Venetian in Hillsboro. The meeting was well attended by family law practitioners from the tri-county area. Outgoing President Laura Schantz officiated the meeting, welcoming incoming President Lauren Walchli. Presenters included the Honorable Donald R. Letourneau, the Honorable Kirsten E. Thompson, Sue Gerhardt, Wendy Peterson, and Lauren Walchli. The following is intended as a synopsis for those who were unable to attend.

Judge Letourneau

Representing Children: The Oregon Judicial Department's website has been updated to add a video designed to educate and assist attorneys in representing children. The video can be found at http://courts.oregon.gov/Washington/Pages/ Attorney411.aspx. This link is not to be cited or disseminated outside OSB membership. Those who have volunteered to represent children for free or at a reduced rate are required to both watch the video and read the ABA rules related to representation of children, as well as to certify to the court both have been done. The court will presumptively, for a child 12 years of age or older, appoint the attorney as a traditional advocate rather than a "best interest" attorney. If the attorney, after appointment, believes the form of representation should be modified, that designation can be changed. The court has developed a form of Order Appointing Legal Counsel for Child(ren) and prefers to use that form, although counsel may draft a form that is substantially similar. You may contact your assigned judge to obtain a copy of the firm, which will also be available in the next revision of the Washington County Supplemental Local Rules. [Note: this committee has completed its mission and is now disbanded.]

<u>Safety First</u>: The program has been accepting clients for approximately one year. Washington County currently has eight slots available; six of those are currently filled. In order to qualify for

this program, there must be a history of domestic violence, defined as physical abuse, between the parents. The domestic violence need not be documented via police reports or FAPA filings; selfreport is sufficient. The program is currently free to participants, but the hours are limited to Tuesday and Wednesday evenings. This supervised parenting program takes place at the Washington County courthouse. Participants are pre-screened for eligibility and suitability. Safety First has recently begun facilitating safe exchanges, also Tuesday and Wednesday evenings at the courthouse. Applications for services (both supervised parenting time and safe exchanges) are available through Judge Letourneau, and can be requested via email: donald.r.letourneau@ojd.state.or.us.

Gun dispossession / prohibition protocol: The courts have expanded their gun dispossession/gun prohibition protocols in Family Abuse Prevention Act restraining orders. The main change is that compliance hearings are now scheduled. If an Order of Surrender is signed, the compliance hearing date is entered on the front page of the Restraining Order. The civil deputy serves a written description of the protocols on the Respondent when the Restraining Order is served.

Judge Thompson

Judge Thompson welcomed Judge Jim Fun to the Family Law bench for what is a commitment of no less than four years. This position is available due to Judge Cobb's requested reassignment to the general civil / criminal team, in addition to continuing her leadership of the Probate Department. Judge Fun, a former prosecutor, became a member of the Washington County bench in 2006, and began serving as the Juvenile Court Judge at that time. He transitioned from Juvenile to the general trial and civil teams in September 2011, and has served in the Law Enforcement Center, Civil motions, and general Civil/ Criminal trial teams.

Rick Menchaca is the newest addition to the Washington County bench. He comes to the bench with experience in criminal defense, juvenile law, and general civil practice. He has been assigned to serve no less than four years as the Juvenile Court Judge. He will preside over Dependency, Delin-

quency, and consolidated Juvenile/Family law cases along with Judge Rini.

Washington County is currently involved in a re-engineering project. The last re-engineering project occurred while Judge Nachtigal was presiding, and resulted in the creation of the family law team of judges. Now-Senior Judge Nachtigal has been chairing the current committee, and has agreed to continue to assist in the process since her retirement on September 1st. She has helped gain the assistance of the National Center for State Courts. Next steps include bringing the NCSC back in for transition planning, communicating changes, and requesting a technical assistance grant. Washington County will be bringing eCourt online in 2016.

Attorneys are encouraged to let judges and court staffs know when they do things right, in addition to when they do things that are confusing or with which you don't agree.

Much has been done by the website subcommittee. The website, hosted by OJD, has been updated to add several videos put together by Judge Raines. These videos discuss the substance and procedure involved in short topical presentations. They include information on how litigants should behave in court. While designed for self-represented individuals, they are a valuable resource for both newer and more experienced attorneys to share with their clients. The videos are in both English and Spanish, and are very helpful. The link for these videos can be found at http://courts.oregon.gov/Washington/Services/Family_Law/pages/family_law_main.aspx.

The pro se forms are in the process of being converted into Word documents. Once converted, they will no longer be available in WordPerfect format. There are other forms available to attorneys that are not available to pro se litigants without going through the court's family law assistance office.

<u>Mediation Subcommittee</u>: The mediation subcommittee focused on getting parties to media-

tion more quickly. The subcommittee was able to modify SLR 12.013, effective February 2013, so that there is no longer a requirement that the parties must attend at least two Kids' Turn sessions prior to participating in mediation. Domestic violence protocols were explored and found to be satisfactory as is.

<u>Kids' Turn</u>: Parties are still required to complete all Kids' Turn sessions. Funding for this program is currently stable, although it costs a bit more (now \$267 per parent) due to prior changes in funding. Parents are encouraged to have their children participate in the child component of the program.

High Conflict Services: Addition of a high-conflict services option is under review. A survey conducted during the first half of 2013 yielded approximately 500 responses, which were supportive of such a program. The program was suggested to the Conciliation Services Advisory Board, also with a favorable response. It is envisioned that services would include the following forms of counseling / mentoring: co-parenting, family counseling, and communication coaching. Participants can be self-referred or referred by court or counsel. The cost will likely be up to \$250 per parent, with a sliding fee scale also available. The Board of Commissioners must approve the fee schedule prior to implementation of the program.

Custody Studies: Conciliation Services can no longer accept all cases, so they are all now screened. Those applying for services first have an intake meeting with an evaluator, who then staffs the case with the team for appropriateness. Examples of cases not likely to be accepted are the "well, I'm the better parent" cases, cases where the parties are very close with regard to a parenting schedule on their own, or cases where DHS has already made a recommendation.

Mediation: Conciliation Services now offers couples counseling, marital counseling, and coparenting counseling. These services are promoted during the orientation session. Up to 4 sessions are available at no cost; additional sessions are \$80 each.

Bonnie Hays Small Animal Shelter helps lost, sick and homeless dogs, cats, and rabbits. When animals are lost, the staff and volunteers work very hard to find their worried owners. They help place homeless animals into loving forever homes. Staff provides veterinary care to sick and injured animals and also spay and neuter clinics. 
