The Honorable Beth Roberts One of "Our Own" Takes the Bench

The casual observer sitting in the gallery of the Law Enforcement Center, aka "LEC," courtroom on March 26 might have been surprised to learn that it was only Day Four of Judge Beth Roberts' appointment as the newest Washington County Circuit Court judge. Having arrived a few minutes before my scheduled interview with Judge Roberts that day, I observed her in action at the end of the 3pm "in custody" docket. Calm, confident, and in control, Judge Roberts appeared to be nothing other than a seasoned pro.

After being appointed by the governor to fill the seat vacated by Judge Rita Batz Cobb at the end of February, Judge Roberts started her first day on the job on March 17. After a few days off for a pre-arranged vacation, Judge Roberts was back on the bench and began her first full week as a judge on March 24th.

Stationed at LEC for the time being, Judge Roberts handles the 8:15am plea docket that includes outof-custody ECR and PV matters, 1:30pm release hearings, and 3pm in-custody matters, ranging from misdemeanors, felonies, contempt, and violations. Her docket will also include some unresolved traffic matters, as well.

Originally from Portland, Judge Roberts lived for several years in Fresno, California, and eventually landed back in Portland, graduating from Portland State University with degrees in business administration and accounting. She graduated from Lewis & Clark Northwestern School of Law in 1993, and went to work in Oregon City from 1994-97 as a solo practitioner, doing contract work, volunteering to represent parties in FAPA hearings, and handling housing, real estate, and domestic relations cases. She offered sliding scale fees to those clients who were referred to her from Legal Aid.

Judge Roberts next worked as a mortgage and compliance officer for the Department of Consumer and Business Affairs, before joining the Washington County District Attorney's Office as a DDA in 1999. At the DA's office, Judge Roberts handled child support enforcement, then transferred to the misdemeanor unit, eventually becoming the Misdemeanor Coordinator before joining the felony unit in 2009. Judge Roberts was also the Drug Court DDA, spending her last day in Drug Court on March 10th.

Drawing upon her accounting skills, Judge Roberts served as treasurer for the Washington County Bar Association, and was on the WCBA Board of Directors from 2002-04. Proud of her history of service in Washington County, with her background as a DDA and her understanding of the Washington County Circuit Court, Judge Roberts is eager to help shape the future of the court and looks forward to being part of the court's revitalization project. She embraces the challenges that face her as a new judge, and is quickly honing her active listening skills, knowing the importance of being "alert and aware" while on the bench.

Judge Roberts hopes that the attorneys who appear in front of her will have good attitudes, will always do their best, and will know not to take what happens in court personally. The attorneys who lingered after court the day I was there expressed to Judge Roberts their appreciation that she provided specific ending dates for probation extensions, rather than simply extending probation by "six months" or "one year." Judge Roberts has clearly set a tone of judicial efficiency and the practical administration of justice in her courtroom.

Although Judge Roberts will miss the collegiality that she enjoyed at the DA's office, she looks forward to becoming more involved in the community outside of working hours. The WCBA extends congratulations and a hearty welcome to Judge Beth Roberts!

Washington County Family Law Bench & Bar Committee

There have been some important developments in the Washington County Family Law Bench & Bar Committee this year.

As you read in the April WCBA newsletter, the Washington County SLR 6.013 regarding status conferences has been modified. Based on a recommendation of the Better Ideas Subcommittee, a subcommittee of the WCBA Family Law Bench & Bar Committee, the SLR requires completion of the UTCR 8 property distribution summary at the time of the status conference. This particular change, effective as of February 1, was designed to enhance the utility of the status conference for settlement purposes. The Better Ideas Subcommittee is now working on identifying the differences among each judge's procedural practices. This subcommittee is polling attorneys in the community regarding these differences. The subcommittee is not making any recommendation at this point, but is simply gathering information. The judges would like to try to unify procedures where practicable.

The Website Subcommittee has continued to add important videos and other materials to the website. This includes several self-help videos created by Washington County Circuit Court to assist self-represented litigants as they maneuver through the family court process. These videos are available in English and Spanish, and star our own Judge Raines. There is a new Child Support Education Subcommittee created to provide education and guidance after the child support rules changed on July 1, 2013. Members of this subcommittee are regularly addressing issues that arise in this area and have brought them to the attention of the Bench & Bar Committee.

Finally, there is a new Judicial Feedback Committee that has been researching ways in which the bar can provide feedback to the Washington County Court. This committee is looking at the National Center for State Courts' recommendations for providing such feedback and/or training tools.
