## CIRCUIT COURT HOURS

### UPDATE



Due to budget cuts and staff restrictions, the Washington County Circuit Court has enacted General Order #261, affecting the hours of telephone and in-person service. Previously, both services were available 8am-5pm.

As of August 6, 2018:

- Telephone Service: 8am-11am; 2pm-5pm
- In-person Service: 8am-noon; 1pm-5pm

These changes affect all departments, staff, windows, clerks, etc. No more noon-hour filings or phone calls.



## TURN SELF IN DOCKET UPDATE

### Washington County Circuit Court

The court has reinstated the Turn Self In ("TSI") Docket at the Law Enforcement Center. This docket allows defendants who have an outstanding warrant due to missing a court date to ask the court to clear the warrant without having to go into jail custody. The procedures for the TSI Docket are as follows:

1. To appear on the TSI Docket the defendant must be charged only with misdemeanors or C felonies.
2. The defendant must e-file a motion asking to be set on the TSI docket. The motion must be served on the assigned DA, and it must state: (1) the charge(s) at issue, (2) the type of hearing that was missed, (3) the date of the missed court date, (4) why the defendant missed the court date, (5) whether there have been any other FTAs in the case, and (6) whether the defendant has had any new criminal charges since the missed court date. Based on the information provided, the court will decide whether the case is appropriate for the TSI Docket.
3. The TSI Docket is held once a week on Fridays at 8:15 a.m. The motion must be e-filed by the end of business Tuesday in order to be set for hearing the Friday of the

same week. Motions filed after Tuesday will be set for the Friday of the following week.

4. If the court grants the request to set the case on the TSI Docket, the outstanding warrant will be placed on hold pending the hearing *but not rescinded*. A warrant will be rescinded only at the direction of the court following the hearing.
5. If the court decides to rescind the warrant, the defendant will have to sign a new release agreement.

# PRACTICING PARENT IN THE MODERN AGE

Sending my twelve-week-old son off to daycare was one of the more jarring moments of my life. As I watched my husband pull out of the driveway with our son snoozing in the backseat, I felt only crushing guilt at continuing my career over taking care of my child at home. My husband, a business attorney, opined that we had already made this choice when we choose to be attorneys and have children. While not wrong, his observation did little to comfort me in that moment.

Nearly three years later, I view that moment quite differently.

In many ways, our culture instills in us the myth that finding a balance between work and family life is some form end state, a form of enlightenment that once achieved, remains fixed forever. But my husband's and my experience has been quite different. Work-life balance is a constant balance, more like a walking a tightrope than a status achievement. And it is a tightrope that constantly changes its shape and structure.

In many ways, the practice of law is evolving for the better in accommodating practicing parents. While there are still some law firms that expect the billable hour to come before anything, the general trend is towards increased electronic communication and more flexible hours – not simply in the law, but all professional fields – have been a boon to younger parents.

Quite simply, most attorneys possess a smart phone which allows for the working parent to continue working from any location. Though not quite as efficient as an actual office presence, at least with a cell phone and laptop computer, most working parents can put out immediate fires from wherever they happen to be. The dreaded phone call that comes from daycare or school is no longer an immediate death sentence to work for the day – merely a speed bump.

But like most great pieces of technology, smart phones are a double-edged sword: they set the expectation of availability. One of the more important lessons I learned as a young parent – nay, still learning – is establishing reasonable boundaries with clients to

manage those expectations. Yes, a smart phone allows me to work on my clients' cases at all hours, but that's neither practical nor desirable. And if communicated clearly at the outset, my experience has been that clients are fairly understanding of this fact.

There can be, however, a great difficulty for many young practicing parents to turn the work email off at the end of the day. Thankfully, features like the ability to change when your smart phone receives or notifies you of work emails can help ease this challenge. It helps give you a defined schedule for when you are devoted entirely or partially to work, and when you are not.

But perhaps the most important tool in a practicing parent's arsenal is support from members of your local bar. It is nothing short of invaluable having the ability to call or email another attorney for advice, comfort, or – sometimes quite crucially – coverage. For attorneys just starting their careers and families, I would urge them to get to know the many other members of the Washington County Bar who are practicing parents themselves, regardless of stage. You will likely find, as I have, a group of attorneys with many collective years of experience and great generosity with time and resources to help other members in times of need.

When it is all said and done, being a practicing parent is never easy. But no one said you must do it on your own.

## LEARNING NEW AREAS OF LAW

### Washington County Law Library

There are many reasons a seasoned practitioner may delve into a new area of law: a friend or family member has a "quick question" for the lawyer they know, an established client has a novel issue, or one simply wants to try something new. But where do you start? Possibly the first thing that comes to mind are case books or Nutshells, both commonly seen in law school. But there are more resources out there.

Sometimes the best starting point is the simplest. Nolo Press has a number of self-help guides. But these are also a great resource for stepping into uncharted legal waters. They will provide a basic overview of a new area of law and a concise introduction to key terms and concepts. A lawyer will easily know which sections are relevant, and will find them a quick and easy way to get the lay of the legal landscape, say for a family practitioner learning about IP. They are often available at your local public library, or currently online through the State of Oregon Law Library.

West's aforementioned Nutshells, or Lexis's similar Understanding titles, are good black-letter introductions to areas of law. More advanced than Nolo, they are still fairly quick and concise ways to learn the core components of new legal topics.

The next level are practice guides. These are practical discussions of "how to" do things in certain areas of law. Once you have the terms and concepts down, these will explain the process from start to finish. For example, Rutter Guides are well known for covering *Federal Civil Procedure Before Trial*, or *Bankruptcy*.

Then of course, for detailed analysis and precise questions, there are the treatises. Some are broad, like *Antitrust Law* by Areeda and Hovenkamp, or specific like *Patent Claim Construction*.

Lexis and West have many materials covering most topics, but there are other publishers. Bloomberg BNA has a number of patent and IP treatises, among others, and Wolters-Kluwer/Aspen has well regarded titles on antitrust law or law related to health or medical science. Smaller publishers also have excellent treatises or practice guides, such as the National Consumer Law Center (NCLC), Practicing Law Institute (PLI), National Institute of Trial Advocacy (NITA), ABA, and James Publishing.

Since OSB members have Fastcase, it is worth noting Fastcase is adding secondary content, including James Publishing and Fastcase's own Full Court Press.



## ARBITRATION CHANGES



**NEW SLR** On September 7, 2018, the court enacts a new SLR that addresses the timing for arbitration hearings. Previously, arbitration hearings had to be held within 49 days of the case being assigned to arbitration, as required by the default rule in UTCR 13.160. Under SLR 13.161, arbitration hearings must be held within 90 days of being assigned to an arbitrator. If either the arbitrator or the parties want to set the hearing beyond the 90-day deadline, a motion must be filed with the court. The full text of SLR 13.161 is on the court's website.

**ARBITRATION COMMISSION** The court is required to have an Arbitration Commission composed of judges, arbitrators, and practitioners. The purpose of the Commission is to oversee the court's arbitration program and provide advisory opinions and feedback to the court regarding arbitration-related matters. On August 1, 2018, the court appointed a new slate of members to its Arbitration Commission: Judge Sims, Judge Hunsaker, John Knowles, Molly Jo Mullen, Justin Johnson, Mark Monson, and Grant Stockton. The Commission with its new membership will be having its first meeting in the next several weeks. If you have any concerns or suggestions related to arbitration practices in Washington County that you would like to raise with the Commission, please contact Judge Hunsaker.
